The Identity Management solution integrates with legacy and back end systems using a variety of integration protocols, where Verification (1:1) and Identification (1:N) processes are allowed with the integrated stations, whether stand-alone computer or e-Gate station. The Identity Management solution supports reading the international standard security documents (cards and e-Passports) and biometrics, and keeps security of storing and exchanging data at a high level.
